Submission Options

A Change of Registered Agent/Office form may be filed using one of the following methods:

E-file: Go to https://tnbear.tn.gov/Ecommerce/RAChangeInstr.aspx and use the online tool to complete the Change of Registered Agent/Office and pay the fee by credit card or debit card. When paying by credit/debit card, there is a service fee charged to the customer. Applicants who do not wish to pay the service fee to file online may choose the "Print and Mail, Paper Submission or Walk-In" option at no additional cost.

Print and Mail: Go to https://tnbear.tn.gov/Ecommerce/RAChangeInstr.aspx and use the online tool to complete the Change of Registered Agent/Office form. Print and mail the filing form along with the required filing fee to the address listed below.

Paper submission: A blank Change of Registered Agent/Office form may be obtained by going to sos.tn.gov and entering SS-4534 in the search bar; by emailing the Secretary of State at TNSOS.CORPINFO@tn.gov, or by calling 615-741-2286. The Change of Registered Agent/Office form should be typed or hand printed in dark blue or black ink.

Walk-in: A blank Change of Registered Agent/Office form may be obtained in person at the Secretary of State's Office at the address listed below.

If submitting by mail, send the completed form and the filing fee together in the same envelope. Mail to:

Completing the Form

1. **Control Number:** The Secretary of State Control Number is a unique number assigned to every corporation, limited liability company and limited partnership formed or qualified in Tennessee. To find yours you may visit: https://tnbear.tn.gov/ECommerce?FilingSearch.aspx

Entity Name: Enter the exact legal name of the business entity as listed on the records of the Tennessee Secretary of State for which you are making a change to the Registered Agent. To find entity information visit: https://tnbear.tn.gov/ECommerce/FilingSearch.aspx

- 2. **Registered Agent Change:** Select if the agent change is submitted by the Business Entity or by the Registered Agent.
- 3. Current Registered Agent: Enter the current registered agent and their complete address.

The address will be verified and formatted to United States Postal Service Address Deliverability guidelines. If the address cannot be recognized as deliverable by the United States Postal Service, the form will be rejected by the Division of Business Services. A post office box is not acceptable for the registered agent/office address.
